# WHAT SHOULD I BRING?

- Government issued photo ID (for both taxpayers if filing jointly)
- Valid Social Security cards or ITIN cards and birthdates for taxpayer, spouse and all dependents that will be on return
- If married and filing jointly, both spouses must be present
- All wage and income statements for 2016 (e.g.: W-2, W-2G, 1099-R forms, 1099-INT, 1099-G, etc.)
- Proof of child care expenses paid in 2016 including: provider's name, address and federal ID number
- A copy of last year's federal and state returns, if available
- For direct-deposited refunds, please have bank account and routing numbers available (voided check is preferable)
- If taxpayer purchased health insurance through the Marketplace/Exchange, Form 1095-A. S/he should receive this form by January 31.
- Proof of Health Care coverage or exceptions if available.
