## WHAT SHOULD I BRING TO MY TAX APPOINTMENT?

- BOTH taxpayers must be present if married and filing jointly.
- Government-issued photo ID (for both taxpayers if filing jointly).
- Valid Social Security cards or ITIN cards and birthdates for taxpayer, spouse, and ALL dependents on tax return.
- All wage and income statements for 2017 (W-2, W-2G, 1099-R, 1099-INT, 1099-G, etc.).
- Proof of child care expenses paid in 2017 including: provider's name, address, & federal ID number.
- Copies of last year's federal and state returns, if available.
- For direct-deposit refunds, please have bank account and routing numbers (voided check is preferable).
- If taxpayer purchased health insurance through the Marketplace/ Exchange, form 1095-A (should receive in mail by January 31).
- Proof of health care coverage or exceptions (not required but helpful).
